## A BILL

Regarding formation the creation of special mill levies for supplemental work study based Career and Technical Education (CTE). Funding for county school districts will be through approval elections that authorize the mill levy.

Be it enacted by The American Legion Boys Nation Senate assembled,

## SECTION 1. SHORT TITLE.

This Act may be cited as the "Career and Technical Education District Funding Act".

Section 2. Enforcement

CTE is deemed an important education curriculum for high school and collegiate students across the entire state. This curriculum needs to be monitored by the Department of Education (DOE). A special subcommittee will be formed within the DOE tomonitor the allocation of these resources.

Section 2 Hosting Recruiters

CTE is necessary for skills and professions to maintain order, maintain basic personal services to live, and necessary professions for the growth and advancement of our communities. Through the extra funding, all teachers will be asked to host at least two trade school recruiters per school year. Inability to do so, results in a 10% dock of funding the next year.

Section 3. Collaboration with Public/Private Entities

CTE curriculum requires public/private partnerships and funding necessary to provide vocational education, tools, and technologies to teach CTE to students. School administration and districts will collaborate with private businesses and schools to provide resources for students.

Section 4. Socioeconomic and Economic Programs

Funding is necessary for CTE education services in excess of other curriculums and is necessary for communities to provide basic maintenance services and also to provide basic needs for the growth and development of community socioeconomic and economic programs as part of the community strategic and economic development plans.

Section 5 Funding.

Through the mill levy tax nationwide, the nation can make in excess of 30 billion dollars. Those 30 billion dollars can directly

fund the expansion of more programs nationwide. Excess funds will be placed within holdings for emergency

Section 6 Renewal/Reconsideration of Bill

If the proposition to authorize a mill levy is approved by the senate, a special committee within the DOE be formed and funded with said mill levy, that the renewal of the mill levy shall occur on the 10th year following the initial

general election where the district and funding were approved.

THEREFORE BE IT ENACTED, By the legislature of Boy's Nation:

That further funding for CTE be done in public/private partnership

utilizing funding from mill levy and private contribution.

THEREFORE BE IT FURTHER ENACTED, Public School districts, public post secondary education institutions are directed to utilize funding for curriculum, CTE technology and education tools, and training for future workforce or continuing certification for existing workforce.
