My fellow Historians,

As the new year is upon us, I would like to extend to all a Happy and Prosperous New Year. May you have success in all your endeavors and, hopefully, make an impact on the Legion organizations in which you are a member.

As a first topic for discussion I would like to address the History Contest conducted at the Fall NEC meeting. I personally believe it went well; however, I know the whole process can be improved. It is one of my goals for the remaining time as National Historian to work with the training group of the Internal Affairs Division to prepare training courses for new Historians serving from the Post through Department levels. I firmly



believe improvement comes with training; and this can only come about if we engage those with the skills necessary to develop training material. I will be calling on some of you to help.

This year we had a total of 46 books submitted for the contest. Of these, only 12 were department level books. This tells me that the majority of Department Historian (including myself) did not take seriously their task of documenting their department's history. This lends itself to the question, "Was a book prepared but just not submitted?" If this is the case, then one must ask why. It is my intent to pursue this over the next few months. There must be an answer; and it is our

responsibility, as part of Team 100, to strive for complete coverage of the events that make our organization great. During its first 100 years The American Legion's preamble was its beacon and guided all as they pursued the well-being of our Veterans and their families. Historians within this great organization recorded these accomplishments for posterity's sake. This year, as we embark on the second 100 years, it is paramount that today's historians be prepared and steadfast in documenting every accomplishment of their organization. Our journey for God and Country must never be allowed to drift into the shadows of obscurity. Hope to see you all at the next National Convention.

Guest: National Historian Frederick (Fred) S. Doten made a few welcoming remarks and then thanked everyone for their help.

**Minutes** of September 10, 2018 and October 10, 2017 were distributed. Motion by PNH Frazier Brinley to change the minutes of Sep 10, 2018 to reflect [IV. New Business, f), 8<sup>th</sup> line – the word union be changed to association.] 2<sup>nd</sup> by Susan Mason. Minutes of the Oct 10, 2017 meeting were accepted. **President Report:** Fae Casper reported that the budget was looked at to ensure it met 501c3 status. She checked with the National Judge Advocate and he reported that clubs are under the National Budget as NADHAL is considered a club. The President proceeded by giving a short history of the previous Treasurer keeping money at home. Current Treasurer Fred Doten reported that the monies associated with NADHAL will be a line item under the National Historian in the National Budget. This eliminates responsibility for filing taxes. This will be completed by May of 2019. He further explained that no budget was required other than a “working” budget.

President then went on to correspondence. Virgil Arling send word that he was sad to not being able to come any more for the judging. Wayne Yee emailed that he wanted to remain Area 9 Vice President.

**Finance Report:** Treasurer Fred Doten stated that the Fall Reviewed Database that Linda had put together was a list of Life Members and Regular Members. He generated a roster that can be tracked over the years for membership. Short term goal was to process money through the National Historian both incoming and expenses using this roster. He will publish an article in the Newsletter in January.

**New Business:**

A new Centennial website is being released. It is a One Stop Shop. The tool Kits are still available and much, much more.

A documentary will be made in Hollywood, using the AL Post in Hollywood. Centennial articles will be in each American Legion Magazine until November 2019. Also looking at doing a Bookazine; starting with the St. Louis Caucus and running till the Indianapolis Convention 2019.

The American Legion is working with the World War One Commission for the “Bells of Peace” to be rung on November 11, 2018.

National Commander Reistad theme this year is TEAM 100.

PNH James Fratolillo as the Judge Advocate reported on a change to the ByLaws. “when President is no longer able to continue.....” is changed to “in case of a resignation, death or .....”.

National Historian Fred Doten spoke about a Resolution that proposes to add video as a category for History Books. He recommended to the National Resolution Committee and Internal Affairs Chair to hold until NADHAL had a say. After discussion with association members a motion was made to table the resolution until the Study Group works on it. Approved unanimously.

NADHAL Dinner: At the National Convention meeting Dan Watrous explained there had been a problem with the Sheraton Hotel in the past with increasing prices especially with new management. A possible place for the dinner had been suggested Indianapolis Post 64. The post agreed and since the RSVP’s mailing the post changed from meals to buffet.
