WHEREAS, There is no official written policy and procedure for a National Representative to attend the funeral or memorial service of a Past National Commander of the Sons of The American Legion; and

WHEREAS, The National Organization of the Sons of The American Legion is currently operating under an outdated Memorandum of Understanding; and

WHEREAS, In past years efforts have been made to have the sitting National Commander or a Past National Commander of the Sons of The American Legion attend such funeral or memorial service; and

WHEREAS, There will be travel expenses incurred by the individual representing the National Organization at such funeral or memorial service; and

WHEREAS, To properly and authoritatively enact an official policy to provide for representation and travel allowance; now, therefore, be it

**RESOLVED, By the National Executive Committee of The Sons of The American Legion, in regular meeting assembled virtually on April 24, 2021, That a National Policy and Procedure titled Past National Commander Funeral or Memorial Service, Addendum 1, be adopted and placed in the Sons of The American Legion Administrative record; and, be it further**

**RESOLVED, That the National Representative be allowed travel expenses not to exceed \$1,000.00 and as outlined in the policy and procedure; and, be it finally**




