Report of Foreign Bank and Financial Accounts (FBAR)

Every year, under the law known as the Bank Secrecy Act, you must report certain foreign financial accounts, such as bank accounts, brokerage accounts and mutual funds, to the Treasury Department. You must also keep certain records of those accounts. You report the accounts by filing a Report of Foreign Bank and Financial Accounts (FBAR) on FinCEN Form 114.

The FBAR is an annual report, due April 15 following the calendar year reported. You're allowed an automatic extension to October 15 if you fail to meet the FBAR annual due date of April 15. You don't need to request an extension to file the FBAR.

Who must File? A United States person, including a citizen, resident, corporation, partnership, limited liability company, trust and estate, must file an FBAR to report:

1. a financial interest in or signature or other authority over at least one financial account located outside the United States, if
2. the aggregate value of those foreign financial accounts exceeded \$10,000 at any time during the reporting calendar year.

Generally, an account at a financial institution located outside the United States is a foreign financial account. Whether the account produced taxable income has no effect on whether the account is a "foreign financial account" for FBAR purposes. This means that many of our members residing in Thailand that have the bank funds required by their respective visa fall into this category and must file the FBAR report. Prepare & Submit

You must file the FBAR electronically through the Financial Crimes Enforcement Network's [BSA E-Filing System](#). You don't file the FBAR with your federal tax return. The FBAR is required by the Treasury Department and is separate from any IRS filing obligations.

Workplace Eye Wellness Month



March is Eye Wellness Month. Each day about 2,000 U.S. workers have a job-related eye injury that requires medical treatment. About one-third of the eye injuries treated in hospital emergency department are preventable when the right PPE is worn and safety precautions are made.

OSHA requires the use of eye and face protection whenever there is a reasonable probability of injury that could be prevented by such equipment. Eye protection should be worn by all employees exposed to the hazards, whether they are working in the area or just passing through. That goes for projects outside the work place.



- Chemicals – When working with chemicals use a face shield or goggles to protect against splashing.
- Particles and Dust – Safety glasses should include side shields to protect from flying objects.
- Hot Work and Other Hazards – When exposed to welding, lasers or fiber optics, be sure to use special-purpose safety goggles and helmets designed specifically for the task.

Contact lenses can't provide significant protection from eye hazards in the workplace. However, there is no evidence that the wearing of contact lenses increases the risk of eye injury. The American Optometric Association believes that workers should be permitted to wear contact lenses in most eye hazardous environments. However, eye protection must be worn over contact lenses exactly as would be required of all workers performing the same job.

Health care workers, laboratory staff, janitorial workers, animal handlers, and other workers may be at risk of acquiring infectious diseases from exposure via the eyes. Infectious diseases can be transmitted through the mucous membranes of the eye as a result of direct exposure (e.g., blood splashes, respiratory droplets generated during coughing or suctioning) or from touching the eyes with contaminated fingers or other objects. The

infections may result in relatively minor conjunctivitis or reddening/soreness of the eye or in a life-threatening disease such as HIV, B virus, or possibly even avian influenza. [\(NIOSH\)](#) Workers in these industries should wear the appropriate eye protection for the hazards. Eye protection should be removed by handling only the portion of this equipment that secures the device to the head (i.e., plastic temples, elasticized band, ties), as this is considered relatively “clean.” The front and sides of the device (i.e., goggles, face shield) should not be touched, as these are the surfaces most likely to become contaminated by sprays, splashes, or droplets during patient care. Non-disposable eye protection should be placed in a designated receptacle for subsequent cleaning and disinfection. [\(CDC\)](#)

In the event of an eye injury, here are the steps to take for first aid.

- Specks in the Eye
 - Do not rub the eye.
 - Flush the eye with large amounts of water.
 - See a doctor if the speck does not wash out or if pain or redness continues.
- Cuts, Punctures, and Foreign Objects in the Eye
 - Do not wash out the eye.
 - Do not try to remove a foreign object stuck in the eye.
 - Seek immediate medical attention.
- Chemical Burns
 - Immediately flush the eye with water or any drinkable liquid. Open the eye as wide as possible. Continue flushing for at least 15 minutes. For caustic or basic solutions, continue flushing while on the way to medical care.
 - If a contact lens is in the eye, begin flushing over the lens immediately. Flushing may dislodge the lens.
 - Seek immediate medical attention.
- Blows to the Eye
 - Apply a cold compress without pressure, or tape crushed ice in a plastic bag to the forehead and allow it to rest gently on the injured eye.
 - Seek immediate medical attention if pain continues, if vision is reduced, or if blood or discoloration appears in the eye.

I get a miscellaneous e-mail question and answer service called ***Quora Digest*** which is a collation of folks writing in on general questions from history, current events, military, science etc. etc. Always something interesting. Of late came the question of why more young people didn't join the VFW or the American Legion.

In reading I remembered in my 30's joining while still actively drilling with my navy unit. Dues were paid but I did not go to a meeting or know what they did. My membership withered and died in not paying the dues. The activity of my unit kept me involved with the military side of life from drills, ACDUTRA (active duty for training), giving classes at meetings, or assigning them to name a few. My sense of comradery was filled.

In reading the opinion and resulting responses (over 54 at this point), I was amazed, puzzled, and jaw dropper effect. Many of the responses were from the Vietnam Era and later. They seemed to be folks in their 50s-60's expressing their experiences when investigating a membership.

In a nutshell they spoke of folks sitting around drinking, telling war stories, racist talk, schemes on 'bilking' the VA out of money, politics, and 'flag waving' mentality. In reading these experiences, they seemed stem from the clubs/bars and not from the meetings. IMO this sounded more like the neighborhood getting together at the local pool hall. If not, a sad affair of VETS as they age or mankind in general. I remember my hometown Vets club had the cheapest drinks. It wasn't limited due to need of clientele so more of a club in name only.

For our unit specifically these are not our issues. Ours is more the lack of potential qualified. My personal reasons were the comradery of other Americans, English being 1st language, cultural similarity of which military was the glue. Don't get me wrong. I enjoy my time in Thailand, but a booster shot of 'hometown' once a month can be just what the doctor ordered.

All in all, these comments coming from our fellow VETS should give us a better insight into who and what we are as a group. They may only be a microcosm of our collectivity. We may not identify with any one of them but certainly a part.


How the Lee's regained ownership of Arlington. Part One

The reason the Federal Government was able to take possession of Arlington was because in 1862, congress passed a law that empowered commissioners to assess and collect tax on real estate in insurrectionary districts. If the taxes were not paid in person, commissioners were granted authority to sell the land.

A tax of \$92.07 was levied on the estate. Because of the fighting and ill health, Mrs. Lee was stuck in Richmond. She sent her cousin to pay the tax but when he arrived, he was told they accept payment from only Mrs. Lee. Thus, declaring the estate in default and put up the property for sale.


An auction was held. The only bidder was the Federal Government. They offered \$26,800 for a property that was worth \$34,100.

While Mrs. Lee was outraged about what had happened to her estate, Gen. Lee had plans to get the estate back, He kept them hidden from all but a



few friends and advisors. He himself took no part in this attempt but did encourage his lawyer to research his case and report to his legal advisor, Francis L. Smith. Gen. Lee confided to his brother that he wanted to regain ownership of the estate and to stop the burial of the dead. This could only be done if he got the property back.


To see if this was even possible, Smith made a clandestine visit to the estate. He determined that it was possible to make it habitable if a wall was built blocking the view of the graves. Unfortunately for him, he told the cemetery supervisor of his plan. The supervisor reported this to Gen. Meigs. Remember, Gen. Meigs was the architect of



the cemetery. This didn't sit well with him and he asked Sec. of War Statton, to make sure the government had clear title to the land. Gen. Lee died in October 1870. The ownership was still unresolved.

Gen. Lee's widow was still obsessed over the loss of her property. She petitioned congress to examine the Federal Governments claim to the land and to estimate the cost of removing the graves. Her petition was bitterly opposed by the senate and was defeated by a vote of 54-4. In June 1873, Mrs. Lee visited Arlington for the last time. What she seen was enough for her to say she did not want to go back and was content to sign over her rights to it. She died 5 months later.

Mrs. Lee's eldest son, George Washington Custis Lee took over the cause. In April 1874, he went to congress with a new petition. All he asked for was an admission that the property was taken unlawfully and requested compensation for it. His petition died in committee.



Custis Lee might have given up but there were signs that the hard feelings between the north and south were softening. Rutherford B Hayes was elected president on his promise of healing the scars of the war. Custis Lee revived his attempt to get Arlington back. This time he went to the courts. Next month find out what happened in the court.
