## **SAFETY MESSAGE**

#### MARCH IS LADDER SAFETY MONTH

In the USA, each year, there are more than 164,000 emergency room-treated injuries and 300 deaths that are caused by falls from ladders.

Falls from ladders are the leading cause of deaths on construction sites. The most frequent ladder injuries include broken bones, broken backs, broken pelvises, and head injuries. Moreover, approximately 20 percent of fall injuries involve ladders, and among construction workers, an estimated 81% of fall injuries treated in hospital emergency rooms involve a ladder. According to the Bureau of Labor Statistics, U.S. Department of Labor (2011) Work-related fatal falls, by type of fall, nearly two-fifths involved falls are from roofs or ladders. Out of 646 falls, 20 percent were from the ladder and 18 percent were

from the roof.

Therefore, it is a <u>must</u> to maintain a 3-point (two hands and a foot, or two feet and a hand) contact on the ladder when climbing, maintain your body near the middle of the step, and always face the ladder while climbing and only use ladders and appropriate accessories (ladder levelers, jacks, or hooks) for their designed purposes (OSHA 2021): <a href="https://search.osha.gov/search?affiliate=usdoloshapublicwebsite&query=ladder">https://search.osha.gov/search?affiliate=usdoloshapublicwebsite&query=ladder</a>.

Additionally, it is important to secure the ladder firmly at the top to prevent it from slipping sideways or the foot from slipping outwards. Hook or tie your ladder (both stiles) to a sturdy anchor point to stop it from slipping.



## **FINANCE MESSAGE**

#### REPORT OF FOREIGN BANK AND FINANCIAL ACCOUNTS (FBAR)

Every year, under the law known as the Bank Secrecy Act, you must report certain foreign financial accounts, such as bank accounts, brokerage accounts, and mutual funds, to the Treasury Department. You must also keep certain records of those accounts. You report the accounts by filing a Report of Foreign Bank and Financial Accounts (FBAR) on FinCEN Form 114.

The FBAR is an annual report, due April 15, following the calendar year reported. You are allowed an automatic extension to October 15 if you fail to meet the FBAR annual due date of April 15. You don't need to request an extension to file the FBAR.

#### **WHO MUST FILE?**

A United States person, including a citizen, resident, corporation, partnership, limited liability company, trust, and estate must file an FBAR to report:

- a financial interest in or signature or other authority over at least one financial account located outside the United States, if
- 2. the aggregate value of those foreign financial accounts exceeded \$10,000 at any time during the reporting calendar year.



Generally, an account at a financial institution located outside the United States is a foreign financial account. Whether the account produced taxable income has no effect on whether the account is a "foreign financial account" for FBAR purposes. This means that many of our members residing in Thailand that have the bank funds required by their respective visa fall into this category and must file the FBAR report. Just follow the onscreen instructions.

You must file the FBAR electronically through the Financial Crimes Enforcement Network's efiling website:

https://bsaefiling.fincen.treas.gov/main.html. You don't file the FBAR with your federal tax return. The FBAR is required by the Treasury Department and is separate from any IRS filing obligations.

# **HISTORY ARTICLE**

#### **BOSTON MASSACRE**



Sight of the Boston Massacre Kings Street

On March 5, 1770, a British soldier was guarding the Kings money which was kept in the Customs House. His name was Private Hugh White. He was one of 2,000 British soldiers occupying the city of 16,000 colonists. The soldiers were there to enforce the King's tax laws. The colonists were not very keen on these laws and believed that there should be "No Taxation without Representation."

There were skirmishes before March 5<sup>th</sup> between the colonists and British Soldiers, but they were not too bloody until the previous February. Among the colonists there were some that



were loyal to the King and some that were not. The

ones that were not were known as Patriates. The Patriates attacked a business that was loyal to the King. A customs officer, Ebenezer Richardson, who lived near the business, tried to break up the fighting by firing a shot through his window. Unfortunately, the bullet struck and killed an 11-year-old boy named Christopher Seider. Several days later, another skirmish broke out between workers and the soldiers. Not much bloodshed, but it set the stage for the Boston Massacre.

On March 5, 1770, while Private White was alone guarding the customs house where the King's money was being stored. Patriots started to gather and threw insults at the soldier and threatened him with violence. Private White kept his cool for at least awhile, but eventually he fought back by striking a colonist with his bayonet. That did not go over very well, and the colonists started to attack, using snowballs, ice, and stones. Soon, the bell that was used for fires began ringing which brought out many colonial men.

Private White eventually fell and called for reinforcements. Captain Thomas Preston showed up with several soldiers. He set up a defensive position in front of the customs house. Now, some colonists could see where this was going and pleaded with the soldiers

not to shoot. Others dared the soldiers to shoot. As the violence escaladed, the colonists used clubs and sticks on the soldiers. Someone supposedly yelled fire, and the soldiers did. The result was five colonists were killed, including Crispus Attucks, a local dock worker of mixed heritage. There were also six colonists wounded.

Someone arrested and jailed Captain Preston and his soldiers. From his jail cell, Captain Preston wrote his version of what happened for publication. The Sons of Liberty leaders, John Hancock and Samuel Adams, incited the colonists to keep fighting. As tensions rose, the British retreated from Boston to Ft. William. Paul Revere joined in by etching an engraving that depicted

the British as starting the conflict even though it was the colonist that had started it.

John Adams, the future president, defended the British. The death penalty was at stake and even though he despised the British, he wanted them to have a fair trial. In the end, Preston was found not guilty and the remaining soldiers who claimed self-defense were found not guilty of murder, but two: Hugh Montgomery and Mathew Kilroy, were found guilty of manslaughter. They were branded on their thumbs as per English law.

Mail delivery during Covid-19 had been suspended for a time, and although it has been resumed, it is not as efficient as before. Make sure that you allow at least 30 days for delivery from Thailand to the USA. Plan ahead and avoid the stress.
