This proposal responds to AI developments by implementing ethical guidelines, mandatory AI trademarking, establishing the Artificial Intelligence Understanding Agency (AIUA) within the Department of Defense, and implementing an AI understanding committee.

Mr. Stutrud of Oregon introduced the following bill;

A BILL

This proposal responds to AI developments by implementing ethical guidelines, mandatory AI trademarking, establishing the Artificial Intelligence Understanding Agency (AIUA) within the Department of Defense, and implementing an AI understanding committee.

Be it enacted by The American Legion Boys Nation Senate assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the "The AI Governance Act".

SECTION 2. Ethical Guidelines.

All companies including but not limited to developing or who are currently developing A.I. including technology like "DeepFakes" and "VoiceFaking" must adhere to an ethical standard of development to A.I. as well as A.I. actors who are determined to fall under these ethical standards by the A.I. committees

The ethical guidelines to which all A.I. developing companies must adhere can be outlined as the following

Proportionality and Do No Harm: AI use should be limited to necessary aims, preventing harm to human life at all costs.

Safety and Security: Address and avoid safety and security risks, assessed by AIUA.

Privacy and Data Protection: Protect privacy, establish data protection frameworks, and secure data in inaccessible databases.

National Interests: Submit AI data to AIUA for maintaining top-quality U.S. AI and safeguarding national interests.

Responsibility and Accountability: Enable traceability and auditing, while securing data from any breach or sale.

Promotion of American Values: A.I. actors should align with American values, including liberty, democracy, and constitutional values.

All A.I. actors to develop A.I. must publish the information to AIUA within 90 days or face fines of up to 20% of the taxable income being confiscated and collected.

SECTION 3. TRADEMARK REGULATION.

All AI-produced works intended for public distribution or commercial use shall include a Digital Coded Trademark, which must be visible or accessible to consumers.

The Digital Coded Trademark shall contain information such as the name or identifier of the AI system, the developers or creators of the AI system, and relevant data necessary for identifying the origin and ownership of the AI-produced work.

Violation of this trademark law could result in up to 20% of all taxable income being collected and fined.

SECTION 4. THE ESTABLISHMENT OF AIUA.

Following the passage of this act the proper funds designated by the proper agencies in regards to a new federal budget will be allocated towards the AIUA.

The establishment of AIUA will be an extension of the Department of Defense and will have designated funds from the Department of Defense budget.

All previous and future A.I. actor regulations and ethical guidelines shall apply to AIUA.

The headquarters of AIUA will be in Washington D.C. and the Department of Defense will coordinate the building, employment, and beginning of the AIUA until the Department of Defense determines AIUA has enough independence to operate on its own.

The AIUA collects, assesses, and stores A.I. data, categorizing it as: Defense Interest, Defense Threat, Safety Threat, Safety Interest, Sector Interest, or Sector Threat.

Defense Interest data is shared with the Department of Defense.

Defense Threat data is shared with Defense, Congress, and other agencies as determined by the AIUA.

Safety Threat data is shared with relevant agencies.

Safety Interest data is shared with appropriate agencies.

Sector Interest data is shared and returned to the A.I. actor.

Sector Threat data is shared with relevant agencies as deemed necessary by the AIUA.

- (2) National Defense Interest, Public Sector Interest, and Private Sector Interest determined A.I. actors will be awarded proportional and requested funds and grants.
- (a) All funding towards these grants will be designated from the federal government and the Department of Defense budget.
- (b) The assessment of funding will be jointly determined by the Department of Defense and AIUA through an audit and thorough process of determination.

(3) AIUA will be overseen by The Department of Defense, but won't have access to all private data until the aforementioned process has been followed.

SECTION 5: THE ESTABLISHMENT OF AN A.I. SENATE AND HOUSE COMMITTEE.

Following the normal procedure, the establishment of A.I. Committees in the United States House and Senate following the passage of this Act.

SECTION 6:

This Bill shall become law at the end of the fiscal year in which it is passed.
